The School is expected to see all circulars on these CBSE websites regularly.
6. With reference to your application on the subject cited above and the inspection of the school conducted by the Committee constituted by the Board on 02/05/2019, it is to inform that on perusal of the inspection report and the documents received along with it, the following deficiency(ies) has(ve) been observed by the Board:-

- Recognition Letter.

\* The school has submitted the Recognition Certificate in the old name of the school. However, the name of school have been changed from Schorlars Public School to Neill World School in Board records and same was approved on the basis of letter dated 18.07.2013 regarding NOC for change name issued by DEO, Morena. Therefore, the school is required to get the school name update in State Govt. records and obtain the recognition certificate in new name on expiry.

- Land certificate.

\* The school again has not submitted the land certificate. The school is required to submit a Certificate of land issued/Certified by the Competent Authority (i.e. Registrar/Tehsildar/Land Revenue) clearly mentioning land area duly indicating compactness of land on which the school is running in the format of Affiliation Bye-Laws.

- Any other conditions required to be imposed

\* IC reported that the area of land is 9351 sq. mts, however, as per records the school have 11000 sq. meters. Therefore, the school is required to submit submit the reason for variation in area of school campus.

Fulfillment of above conditions is mandatory in nature and the school does not fulfill the mandatory conditions for affiliation. The application of the school under reference cannot be processed any further in the light of deficiencies mentioned above.

The school is therefore directed to submit specific compliance on all the points mentioned above with supporting documentary and photographic evidence **within 30 days** of issuance of this letter. The compliances in response to the deficiencies are required to be submitted **ONLINE** only. Compliances/ Representations received after given time or offline (hard copies) will not be entertained.

**All the documents (each page) must be signed by the Manager and Principal of the school and the same should be scanned and uploaded on the Board's website on the link [Compliance User Login](#).**

The school may ensure that the documents to be submitted should be **scanned properly with the help of a scanner**. The pdf files prepared by clicking images with mobile phones generally result in illegible, hazy and dark documents which are not acceptable. The pdf files may have more than one page.

Please note that if the compliance report is Not received within the specified time period, the application of the school will be rejected without further intimation.

It is further informed that school shall not start classes under CBSE pattern (IX/X/XI/XII as the case may be) without grant of affiliation by the Board, otherwise the Board will not be responsible for any consequences arising out of it.
